Referral Program Contract Agreement

1. Referral Program Eligibility:

- a. The Referring Student must be currently enrolled at the School.
- b. The Referring Student must refer a new student, the Referred Student, who has not previously contacted the School.
- c. The Referred Student must mention the Referring Student's name as the referrer during the registration process.
- d. Both the Referring Student and the Referred Student must pay their tuition fees in full and on time.
- e. Both the Referring Student and the Referred Student must attend the same academic term.

2. Discount Benefit:

a. If the Referring Student successfully refers the Referred Student, and both students pay their tuition fees in full and on time, the Referring Student will be eligible for a one-time 10% discount on their tuition fees for the upcoming academic term.

b. If the Referred Student pays their tuition fees in full and on time, they will be eligible for a one-time 5% discount on their tuition fees for the upcoming academic term.

3. Payment Plan Option:

a. The School understands that students may choose to pay their tuition fees through a payment plan.b. If either the Referring Student or the Referred Student opts for a payment plan, both students must still pay their tuition fees in full and on time according to the agreed-upon payment schedule to remain eligible for the discounts.c. Failure to make timely payments or defaulting on the payment plan will result in the revocation of the discounts previously granted to both students.

4. **Revocation of Discounts:**

a. If either the Referring Student or the Referred Student fails pay their tuition fees in full and on time, the discounts previously granted to both students will be revoked.

b. The revocation of the discounts will be effective from the date it is determined that either student has failed to meet the enrollment and payment requirements.

c. Once the discounts are revoked, both students will be responsible for paying the remaining tuition fees without the discounts applied.

5. Referral Confirmation:

a. The School will review and verify the referral provided by the Referring Student to confirm eligibility for the discounts.

b. The School reserves the right to investigate and validate the referral, and its decision regarding eligibility for the discounts is final.

6. Limitations and Modifications:

a. The School reserves the right to modify or terminate the referral program at any time without prior notice.b. Any modifications to the referral program will not affect the discounts already granted to eligible students before the modification.

7. Governing Law and Jurisdiction:

a. This Agreement shall be governed by and construed in accordance with the laws of the State of Hawaii.

b. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of the State of Hawaii.
